DIRECTIONS

From Route 95 (Driving North):

Exit 10 (Noroton Heights). At the top of the ramp, turn left onto Noroton Avenue. Go to third traffic light (gas station on the right); turn left onto West Avenue. Go to second traffic light; turn right onto Hollow Tree Ridge Road. Follow Hollow Tree Ridge Road to the second stop sign (Weeburn Country Club will be right in front of you). Take a left and continue on Hollow Tree Ridge Road. Take second left onto Nolen Lane (after Hollow Tree Ridge Road bends sharply to the right). We are the second house on the left.

From Route 95 (Driving South):

Exit 10 (Noroton Heights). At end of the ramp, turn left onto Ledge Road. Follow Ledge Road to traffic light; turn right onto Noroton Avenue. Go to second traffic light (gas station on the right); turn left onto West Avenue. Go to second traffic light; turn right onto Hollow Tree Ridge Road. Follow Hollow Tree Ridge Road to the second stop sign (Weeburn Country Club will be right in front of you). Take a left and continue on Hollow Tree Ridge Road. Take second left onto Nolen Lane (after Hollow Tree Ridge Road bends sharply to the right). We are the second house on the left.

From Merritt Parkway (Driving North):

Exit 37 (New Canaan/Darien). At bottom of ramp, turn right onto Route 124 (South Avenue/Mansfield Avenue). Take first right onto Talmadge Hill Road. Take first left (small church on the left) onto Hollow Tree Ridge Road. Follow Hollow Tree Ridge Road for approximately 1.9 miles. Turn right onto Nolen Lane. We are the second house on the left.

From Merritt Parkway (Driving South):

Exit 37 (New Canaan/Darien). At end of the ramp, turn right onto Route 124 (South Avenue/Mansfield Avenue). Take second right (first right will be to go north on Merritt Parkway) onto Talmadge Hill Road. Take first left (small church on the left) onto Hollow Tree Ridge Road. Follow Hollow Tree Ridge Road for approximately 1.9 miles. Turn right onto Nolen Lane. We are the second house on the left.
